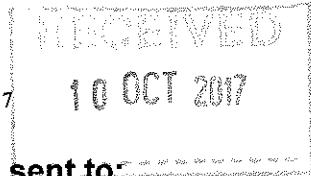


Notice Of Members Registerable Interests
