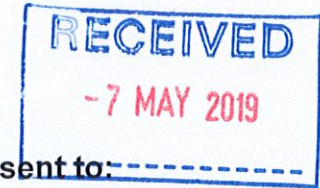



<p><b>Employment or Business</b> You should give a brief description of the type of activity carried on, for example accountant, teacher, etc. You should show every employment, office trade or profession. You are not required to declare what income you receive but must give the name of your employer or of any firm of which you are a partner or a remunerated director. If you are employed by a public authority of any sort your employer will be the authority.
